

## **2012 AIDS Outreach Committee's Holiday Adopt-a-Family Project**

This year 66 law firms, individuals, and local organizations participated in the AIDS Outreach Holiday Adopt-a-Family Project. In all, 59 families and 19 individuals were helped by this program. This represents 81 adults and 159 children, totaling 240 people. This surpassed 2011's Holiday Adopt-a-Family Project by 19 participants and 67 people.
